### Document Management System

BatchMaster Document Management System (DMS) is a feature rich desktop and cloud document management system that stores, creates, tracks, retrieves, and manages all types of documents. It encompasses the entire document lifecycle within an organization from the creation and publication of content, to archival and finally the retention or disposal of content in a much secure way. Automating manual document control with sign-off and change control, it improves efficiency while meeting compliance requirements. Categorizing documents, maintaining versions and change logs, the system catalyzes audits and makes meeting compliance much easier.

- Acts as a central library to stores all the documents together
- Maintains the audit trail of who has viewed a document, when it was accessed, and how it may have been modified
- Let's you number or index documents via meta-data with different "search" terms
- Organize and segregate your documents into different categories like: policies, applications, etc.
- Know the current stage of document lifecycle: Draft, Pending for Approval, Approved, Active, Obsolete and Inactive.
- Secures the document through a selective restriction of access to documents via passwords, e-signatures, other authentication levels, etc.
- Generate an alert for the specified electronic distribution list that the document has been released
- Keeps a track of all versions of a document, and lets you see what has changed, who did it and when the change was made
- Multiple people can work and edit the same document in a synchronized way without altering each other's work and maintaining different versions of it







### Non-Conformance

The Non-Conformance module of BatchMaster QMS helps to log an issue, upload any evidence, classify the type, associate severity, and assign it to the intended authority for managing it. Also, it records decisions regarding "Immediate Corrective Actions".

By managing the life cycle of nonconformance events, along with cost tracking and assignment of user responsibility at every stage, it automates manual record keeping and provides detailed statistical analysis. Moreover, the Non-conformance Report helps meet FDA requirements by listing all the discrepancies that need to be documented in regards to a product, process or procedure.

- Store the possible causes of nonconformance
- Create the nonconformity records
- Ability to specify the type of the document in reference to which the non-conformance is being recorded, like SO Delivery, PO Receipt, Production, QC, Inspection, or Other types of records
- User, date and time stamping on all records
- Records of all the activities undertaken to resolve the nonconformity

# Corrective & Preventative Action

Corrective and Preventative Action of BatchMaster QMS acts as a central point to manage continuous improvement of products, and operations. It deals with the tracks the impact of Corrective and Preventative Actions, and measure reduction over time.

- CAPA processes can be grouped on the basis of their characteristics
- Create records after examining the reason for quality failure
- · Record the details about its actions
- · Specify the urgency level of the CAPA
- Mention the user who is assigned the CAPA task
- Specify details like the department for which you are defining the CAPA, date on which CAPA process is scheduled to be completed, etc.
- Select the appropriate reason for CAPA
- Specify the corrective measures taken to prevent the recurrence of non-conformance
- Perform verification and mention the effectiveness of CAPA or any other vital information related to CAPA verification process
